#### 28 December 2017

## Domestic payments ordered using electronic banking systems:

- orders of payment to the Social Insurance Institution and to tax authorities made by 20:00 will be executed in the current year. Orders made after 20:00 will be executed on 2 January 2018.
- **Direct Debit** orders made by 20:00 will be executed in the current year. Orders made after 20:00 will be executed on 2 January 2018.
- Postal Orders made by 20:00 will be sent to the Postal Operator for execution in the current year. Orders made after 20:00 will be sent on 2 January 2018.

### Domestic payments ordered using SWIFT MT 101 messages:

orders of payment to the Social Insurance Institution and to tax authorities made by 15:00, will be executed in the current year. Orders made after 15:00 will be executed on 2 January 2018.

#### Domestic payments ordered in paper form:

orders of payment to the **Social Insurance Institution** and to **tax authorities** made by 15:00, will be executed in the current year. Orders made after 15:00 will be executed on 2 January 2018.

## Domestic payments ordered using electronic banking systems:

orders needing the **ELIXIR** system for their execution made until 12:00, will be executed and the money transferred to the beneficiary's bank in the current year.

Orders made between 12:00 and 20:00, will be executed in the current year, but the beneficiary's bank will receive the money on 2 January 2018.

Orders made after 20:00 will be executed on 2 January 2018.

- orders needing the **SORBNET2** system for their execution made until 14:00, will be executed in the current year. Orders made after 14:00 will be executed on 2 January 2018.
- orders of Mass Payment and Mass Payment Plus made until 11:40, will be executed and the money transferred to the beneficiary's bank in the current year.

Orders made after 20:00 will be executed on 2 January 2018.

- **Direct Debit** orders, mass and retail ones, made until 20:00 will be executed on 2 January 2018. Orders made after 20:00 will be executed on 3 January 2018.
- Postal Orders made by 20:00 will be sent to the Postal Operator for execution on 2 January 2018. Orders made after 20:00 will be sent on 3 January 2018.

### Domestic payments ordered using SWIFT MT 101 messages:

- orders needing the **ELIXIR** system for their execution made until 12:00, will be executed and the money transferred to the beneficiary's bank in the current year.
- Orders made between 12:00 and 15:00 will be executed in the current year, but the beneficiary's bank will receive the money on 2 January 2018.

Orders made after 15:00 will be executed on 2 January 2018.

orders needing the **SORBNET2** system for their execution made until 14:00, will be executed in the current year. Orders made after 14:00 will be executed on 2 January 2018.

#### Domestic payments ordered in paper form:

orders needing the ELIXIR system for their execution made until 10:00, will be executed in the current year. Orders made after 10:00 will be executed on 2 January 2018.

- SEPA Transfer Orders and EuroEkspres Transfer Orders made until 13:00 will be executed in the current year. Orders made after 13:00 will be executed on 2 January 2018.

#### Foreign payments ordered using SWIFT MT 101 messages:

• foreign payment orders (FX foreign transfers, FX transfers to an account with another domestic bank, orders to pay the collection fee) made by 11:00 will be executed in the current year. Orders made after 11:00 will be executed on 2 January 2018.

#### Foreign payments ordered in paper form:

• foreign payment orders (FX foreign transfers, FX transfers to an account with another domestic bank, orders to pay the collection fee) made by 10:00 will be executed in the current year. Orders made after 10:00 will be executed on 2 January 2018.

Other order types will be executed as usual and during standard hours.

#### Information on prepaid cards orders execution

- Prepaid card orders made until 14:00 on 15 December 2017, will be executed and sent until 22 December 2017. Orders made after 14:00 on 15 December 2017 will be executed on a current basis and sent starting from 27 December 2017.
- **Prepaid card** orders made until 14:00 on 22 December 2017 will be executed and sent in the current year. Orders made after 14:00 on 22 December 2017 will be executed and sent between 2 and 3 January 2018.

### Information on loan payments and transfer of funds for loan obligations repayment

- Orders for **loan payments** (in particular those to be executed in the form of domestic or foreign transfers) made by 15:00 on 28 December 2017 will be executed in the current year. Orders made after 15:00 on 28 December 2017 will be executed on 2 January 2018.
- Funds for **repayment of loans** transferred to indicated accounts by 11:00 in the period between 27 and 29 December 2017 will be settled on that day.
- Funds for **repayment of loans** on 29 December 2017 should be transferred to indicated accounts for repayment on the preceding day, i.e. on 28 December 2017, at the latest. Funds transferred on 29 December 2017 will be settled no earlier than on 2 January 2018.
