# Information about domestic and foreign payment orders

# 29 December 2016

#### **Domestic payments**

- on 29 December 2016, paper orders of payment to the Social Insurance Institution and to tax authorities should be made by 15:00 if the orders are to be executed and the funds are to be transferred to the beneficiary's bank in the current year orders placed after 15:00 will be executed on 30 December, but the funds will be transferred to the beneficiary's bank on 2 January 2017;
- on 29 December 2016, electronic orders of payment to the Social Insurance Institution and to tax authorities should be made by 19:00 if the orders are to be executed in the current year orders placed after 19:00 will be executed on 30 December, but the funds will be transferred to the beneficiary's bank on 2 January 2017;
- electronic Mass and Retail Direct Debits, to be executed in the current year, should be made by 29 December 2016, 19:00 – orders made after 19:00 will be executed on 2 January 2017;
- **postal orders**, to be sent to the Postal Operator for execution in the current year, should be made **by 29 December 2016**, **19:00** orders made after 19:00 will be sent to the Postal Operator for execution on 2 January 2017;

# 30 December 2016

## **Domestic payments**

- on 30 December 2016, paper domestic payment orders should be made by 10:00 this will result in execution of orders and transfer of funds in the ELIXIR system to the beneficiary's bank in the current year orders made after 10:00 will be executed on 2 January 2017;
- on 30 December 2016, paper domestic payment orders should be made by 10:00, in case of orders to be executed in the SORBNET2 system in the current year orders made after 10:00 will be executed on 2 January 2017;
- on 30 December 2016, electronic mass domestic payment and mass domestic payment plus orders should be made by 11:10 this will result in execution of orders and transfer of funds to the beneficiary's bank in the current year. Orders made between 11:10 and 19:00 will be executed in the current year, but the funds will be transferred to the beneficiary's bank on 2 January 2017. Orders made after 19:00 will be executed on 2 January 2017;
- on 30 December 2016, electronic domestic payment orders should be made by 11:30 this will result in execution of orders and transfer of funds in the ELIXIR system to the beneficiary's bank in the current year. Orders made between 11:30 and 19:00 will be executed in the current year, but the funds will be transferred to the beneficiary's bank on 2 January 2017. Orders made after 19:00 will be executed on 2 January 2017;
- on 30 December 2016, SWIFT MT101 domestic payment orders should be made by 11:30 this will result in execution of orders and transfer of funds in the ELIXIR system to the beneficiary's bank in the current year. Orders made between 11:30 and 15:00 will be executed in the current year, but the funds will be transferred to the beneficiary's bank on 2 January 2017. Orders made after 15:00 will be executed on 2 January 2017;
- on 30 December 2016, SWIFT MT101 and electronic domestic payment orders should be made by 14:00, in case of orders to be executed in the SORBNET2 system in the current year orders made after 14:00 will be executed on 2 January 2017;
- on 30 December 2016, electronic mass and retail direct debits should be made by 19:00, in case of orders to be executed on 2 January 2017 orders made after 19:00 will be executed on 3 January 2017;
- **postal orders** made **on 30 December 2016, by 19:00** will be sent to the Postal Operator on 2 January 2017 orders made on 30 December 2016, after 19:00 will be sent to the Postal Operator on 3 January 2017;

#### **Foreign payments**

- on 30 December 2016, paper foreign payment orders (FX foreign transfers, FX transfers to an account with another domestic bank, orders to pay the collection fee) should be made by 10:00, in case of orders to be executed on the same day orders made after 10:00 will be executed on 2 January 2017;
- on 30 December 2016, SWIFT MT101 or electronic foreign payment orders (FX foreign transfers, FX transfers to an account with another domestic bank, orders to pay the collection fee) should be made by 11:00, in case of orders to be executed on the same day orders made after 11:00 will be executed on 2 January 2017;
- on 30 December 2016, electronic SEPA transfer orders and EuroEkspres transfer orders should be made by 13:00, in case of orders to be executed on the same day orders made after 13:00 will be executed on 2 January 2017;



#### Information on payment cards orders execution

- mBank CompanyNet electronic prepaid card orders to be executed before Christmas (cards sent by the bank) should be made by 14:00, 16 December 2016 at the latest applications filed after the deadline will be processed by the bank on an ongoing basis; however, due to the holidays the cards will not be sent until 27 December 2016;
- mBank CompanyNet electronic prepaid card orders to be executed in 2016 (cards sent by the bank) should be made from 14:00, 16 December until 11:00, 23 December 2016 at the latest applications filed after the deadline will be processed on an ongoing basis; however, due to the holidays the cards will be sent on 2 and 3 January 2017;

## Information on loan payments and transfer of funds for loan obligations repayment

- orders for loan payments (in particular those to be executed in the form of domestic or foreign transfers in 2016) should be made by 29 December 2016, 15:00 orders sent after that deadline will be executed on 2 January 2017;
- funds for repayment of loans in the period between 27 and 29 December 2016 should be transferred to accounts for repayment by 11:00 of a given day at the latest;
  funds for repayment of loans on 30 December 2016 should be transferred to accounts for repayment on the
- funds for repayment of loans on 30 December 2016 should be transferred to accounts for repayment on the preceding day, i.e. on 29 December 2016 funds that will be received on 30 December 2016 can be settled no earlier than on 2 January 2017;

#### **Transactions via the Financial Markets Sales Department**

on 23 December 2016 concluding transactions by phone and submitting offers (phone as well as FX platform) via the Financial Markets Sales Department will be possible between 8:00 and 15:00. Concluding transaction through the FX platform will be possible during the regular business hours;
