This change will not impact the cost of transactions for clients because the commission will substitute the so far used currency conversion commission and the Bank's currency spread.



^a From 13 May 2014 the settlement currency for Visa cards in the payment organisation was changed from EUR to PLN. The change will lead to a simplification of settlements of foreign transactions – all transactions executed in a foreign currency will be directly converted by Visa into PLN.
