24 December 2015

Domestic payments

- on 24 December 2015, paper domestic payment orders should be made by 10:00 this will result in execution of orders and transfer of funds in the ELIXIR system to the beneficiary's bank on the same day orders made after 10:00 will be executed on 28 December 2015;
- on 24 December 2015, paper domestic payment orders should be made by 10:00, in case of orders to be executed in the SORBNET2 system on the same day – orders made after 10:00 will be executed on 28 December 2015;
- on 24 December 2015, electronic payment orders should be made by 11:30 this will result in execution of orders and transfer of funds in the ELIXIR system to the beneficiary's bank on 24 December 2015. Orders made between 11:30 and 18:00 will be executed on the same day, but the funds will be transferred to the beneficiary's bank on 28 December 2015. Orders made after 18:00 will be executed on 28 December 2015;
- on 24 December 2015, SWIFT MT101 domestic payment orders should be made by 11:30 this will result in execution of orders and transfer of funds in the ELIXIR system to the beneficiary's bank on 24 December 2015. - mBank CompanyNet electronic prepaid card orders to be executed in 2015 (cards sent by the bank) should be made between 14:00, 17 December 2015 and 11:00, 24 December 2015 at the latest. Orders made after this time will be executed on a current basis; however, due to the non-trading days, the cards will be sent between 4 and 5 January 2016;

Information on loan payments and transfer of funds for loan obligations repayment

- Orders for loan payments (in particulars those to be executed in the form of domestic or foreign transfers in 2015) should be made by 15:00, 30 December 2015 at the latest. Instructions submitted after this time will be executed on 4 January 2016.
- Funds for repayment of loans in the period between 28 and 30 December 2015 should be transferred to accounts for repayment by 11:00 of a given day at the latest.



Funds for repayment of loans on 31 December 2015 should be transferred to accounts for repayment one day before i.e. on 30 December 2015. Funds transferred on 31 December 2015 may be settled no earlier than on 4 January 2016.
